Annex 1 -Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

1. Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
2. Every supply of alcohol under the premises licence must be made or authorised by the management committee

Mandatory conditions where licence authorises exhibition of films

1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
2. Where the film classification body is specified in the licence, unless subsection 3b applies, admission of children must be restricted in accordance with any recommendation made by that body.
3. Where:
 - the film classification body is not specified in the licence, or
 - the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4. In this section

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1.984 (c.39) (authority to determine suitability of video works for classification).

Recorded background music is unrestricted.

Annex 2 -Conditions consistent with the operating schedule

Licensable Activities

Plays

IndoorsThe hall is available to rent by theatre groups, amateur dramatic societies and the like, for both the rehearsal and performance of plays. Provision of plays may include specialist lighting, effects, pyrotechnics and amplified music etc.

Films

Indoors

The hall is available to rent by clubs and film societies and the like, all types of films may be shown to the appropriate audience relevant to the film's classification.

Indoor Sporting Events

The hall is available to all persons, clubs & societies wishing to hire it as a venue for, Indoor Bowls, Table Tennis, Darts, Badminton, Football, Snooker and the like

Boxing or Wrestling Entertainment

Indoors

The hall is available to rent as a venue for practice, demonstration and competitions by any boxing, wrestling and similar societies.

Boxing or wrestling entertainment, may include the provision of "theatrical effects" and amplified music etc

Live Music

Indoors.

All areas of the hall are available to hire by anyone wishing to organise Parties, Dances, Social Functions and the like, at which the performance of live music may form part of the event.

Provision of Live Music may include both amplified and unamplified music, and may be by professional or amateur musicians & performers

Recorded Music

Indoors

All areas of the hall are available to hire by anyone wishing to organise Parties, Dances, Social Functions and the like at which the playing of recorded music may form part of the event.

Play of recorded music will involve amplification either via the hall's volume restricted sound system or brought in DJ equipment etc.

Performance of Dance

Indoors

All areas of the village hall are available to hire by anyone for the purpose of dancing or teaching dance & ballet etc.

Performance of dance will normally be on the existing stage or in the main hall. Performance of dance may include specialist lighting, effects, pyrotechnics and amplified music etc.

Any Other Regulated Entertainment

Indoors

The hall is available, subject to management committee approval, to all persons, clubs & societies wishing to hire it as a venue for their activities. These activities may include poetry recitals, book clubs, public speaking performances etc and any similar activities not covered by (e)(f) or (g).

Facilities for Making Music

Indoors

All areas of the village hall are available to hire by anyone for the purpose of making music.

The hall is available to hire as a "Band Practice" venue.

Normally all instruments will be bought in by individual musicians & performers.

Facilities for Dancing

Indoors

The village hall is available to rent by all persons, groups, clubs & societies, for many varied activities, together with social and fund raising events such as dances & discos etc. Small social functions may be held in the Clubroom, larger functions will be held in the Main Hall.

Provision of facilities for dancing may include amplified music reproduction.

Other Entertainment Facilities

Indoors

The village hall is available to rent by all persons, groups, clubs & societies, for many varied activities, some of which may not be covered by (i) or (j) above.

Indoors

Supply of Alcohol

On the premises

Concern for Children

None envisaged.

As part of the hiring Terms and Conditions, the Village Hall Management Committee & authorised bookings clerk reserve the right to refuse certain types of bookings, which would give concern in respect of children or vulnerable persons in general.

Embedded Restrictions to be Removed

All "Conditions relating to Regulated Entertainment" as currently imposed on the current licence.

Licensing Objectives

General

- All regular users and event organisers are made aware of, and are bound by conditions of hire documents which contain clauses relating to the provision & sale of alcohol etc. (copies attached).
- The Management Committee where possible ensure that all regular user groups of the premises are informed of changes in any legislation relating to their activities.
- All user groups are given training in accordance with the adopted "Alcohol & Children Policy".
- The Management Committee reserve the right to require any hirer(s) to apply for an individual TENs licence for specific events, if the booking clerk of Management Committee deem this to be appropriate.

The Prevention of Crime and Disorder

- All regular users and event organisers are made aware of, and are bound by conditions of hire documents which contain clauses relating to General Conduct, Safety, Alcohol etc. (copies attached).
- The village hall has extensive illumination.
- Drugs and Alcohol prohibition notices are prominently displayed in the entrance foyer of the hall.

Public Safety

- All regular users and event organisers are made aware of, and are bound by conditions of hire documents which contain clauses relating to Public Safety etc. (copies attached).
- Emergency procedure instructions are prominently displayed in the entrance foyer.
- The hall is well equipped with an automated fire alarm & emergency lighting.
- The management committee undertake fire risk assessments twice yearly.
- Regular user groups are encouraged to have trained first aiders as members.
- First aid facilities are provided in the hall.

The Prevention of Public Nuisance

All regular user and event organisers are made aware of, and are bound by conditions of hire documents which contain clauses relating to public nuisance, noise levels, attendees conduct and the like (copies attached).

The Protection of Children From Harm

All user groups and event organisers are required to comply with all sections relevant to children in the "Standard Conditions of Hire".

All persons serving alcohol at any event are required to sign & adhere to the "Community Premises - Alcohol and Children Policy" document which GOVCH management committee have adopted (copy attached for info).

Conditions agreed with Harrogate Borough Council's Environmental Protection Team

1. Noise from amplified and non-amplified music, singing and speech arising from regulated entertainment at the premises (between the hours of 23:00 and finish of regulated entertainment) shall not be audible inside habitable rooms of noise sensitive properties.

2. Prominent, clear notices shall be displayed at all entrances, drinking areas and exits requesting patrons and staff to respect the needs of local resident and leave the area quickly and quietly
